### New Ordinance to regulate Short-Term Rental

Short-Term Rental is any dwelling unit which is rented or leased for overnight lodging to transient guests for a period of not less than one (1) day nor more than thirty (30) consecutive calendar days. Short-term rentals shall include vacation homes but shall not include bed and breakfasts/inns, boarding houses, hotels, motels, hospitals, nursing homes, or dormitories as defined in this Ordinance. The ordinance specifies that such use is not permitted in the Primarily Residential Districts. This use is only permitted in the Primarily Business Districts.

- The property owner must provide a Certificate of Insurance to the Borough evidencing a minimum of \$1,000,000 commercial liability insurance coverage for the use.
- The property owner must provide evidence of a valid Lancaster County hotel excise tax certificate and a Pennsylvania Sales, Use, and Hotel Occupancy Tax license.
- The use requires the specific designation of a person in charge, either the property owner or another person who must reside or have an office within fifteen (15) miles of the short-term rental property and acts as the legal agent for the owner.
- The use shall comply with all applicable Borough Ordinances and regulations, including any and all building code requirements for a commercial building.
- Inspection and approval by the Zoning Officer or other designated Borough agent is required before Certificate of Occupancy will be issued.
- The use must apply to the entire property with the number of units that exist at the time of approval. No additional units can be created after approval.
- A short-term rental unit may not be located in a structure that contains one or more other dwelling units used for non-transient living quarters.
- Short-term rental units shall be permitted only in structures/buildings that are located at least twenty (20) feet from any residential dwelling not located on the same property as the short-term rental unit.
- Overnight occupancy is limited to no more than two (2) persons per bedroom.
- The maximum number of day guests at any one time shall not exceed ten (10) persons, inclusive of overnight guests.
- No additional bedrooms may be added or created within the dwelling unit after the approval of the use. Existing non-bedroom spaces may not be converted into additional bedrooms. The number of bedrooms shall be limited to that which existed in the dwelling unit at the time of approval.
- The property must have a minimum of one (1) off-street parking space per bedroom, and guests may not park more cars on site than the number of off-street parking spaces available.
- The use must comply with all terms and conditions of any other short-term rental ordinance provisions and/or licensing program established by East Petersburg Borough.

### **Keep All Batteries Out of Trash & Recycling Bins**

Alkaline Batteries (single-use): Collect in battery/storage bag. Although not a fire risk, these should be kept separate so they can be disposed of properly. Battery bags are available at the borough office. Battery bags should be put at the curb on the ground next to your bins on trash day. There is a bin at the borough office for batteries also.



### **Rechargeable Batteries**

Don't store end-of-life batteries. Dispose of immediately. Examples of rechargeable batteries:

The bags will then be brough to LCSWMA.

## **BE WISE WHEN YOU FERTILIZE!**

Preventing fertilizer loss keeps your lawn healthy, saves you money, and protects our waterways.

It is important to properly assess your lawn's nutrient needs prior to selecting and applying fertilizer.

The Pennsylvania Department of Agriculture is working with homeowners and businesses to promote best practices and educational opportunities for understanding how to best meet our shared goals.

### Fertilizer Law

On July 11, 2022, Pennsylvania enacted a new fertilizer law that updated requirements for both manufacturers and applicators of fertilizer.

- label modifications
- fee updates
- turf nutrient limitations
- application restrictions

### Who is a Fertilizer Applicator?

The term "applicator" refers to anyone who applies fertilizer, including lawn care professionals, farmers, and homeowners.

### Calibrate

Follow the directions on the fertilizer label and use a fertilizer spreader that is properly calibrated.

### Know The Rate

Select a fertilizer that is appropriate for the lawn's needs.

Phosphorus cannot be applied unless: establishing or repairing turf OR a soil test indicates a phosphorus deficiency.

Nitrogen is limited to:

- 0.7 pounds available N per 1000 ft<sup>2</sup> per application
- 0.9 pounds total N per 1000 ft2 per application


### **Environmental Conditions**

- · Do not apply near water, storm drains, or drainage ditches.
- Maintain a 15-foot buffer from waterways.
- Do not apply if heavy rain is expected.
- Do not apply if ground is snow-covered or frozen.
- Apply product using a properly calibrated fertilizer spreader.
- Apply only to intended application site.
- Fertilizer that lands on an impervious surface (like roads, sidewalks, driveways) must be swept back onto turf.

### Follow the 4Rs of Nutrient Management:

Right Source, Right Rate, Right Time, Right Place.






### East Petersburg Borough Zoning/Building Permits

### Decks

- A permit is required for a deck.
- Setbacks vary according to Zoning District.





### Sheds

- A zoning permit is required for all sheds (including | prefab sheds).
- No sheds are permitted in the front yard.
- Check for easements on the property. Sheds are not allowed in storm water easements.



### Patios

- A zoning permit is required for a patio.
- Setbacks vary according to Zoning District.



- Need to check with the Zoning Officer on the maximum allowed lot coverage, varies with Zoning District.
- Check for easements on the property.

### Residential Fences

- Zoning permits are required for fences, including replacing an already existing fence.
- A corner lot is considered to have two front yards.



Fences in the front yard must be of an "open type" picket. wrought iron or split rail and may not exceed 4 feet in height.



### Driveways, Walkways, Sidewalks


Zoning permits are required for new driveways, sidewalks and walkways or for replacements/



expansions of any of these, as well as resurfacing a driveway. Note: Asphalt resealing does not require a permit.

### Residential Pools

- Permits are required for all above or in-ground pools greater than 24 inches in depth.
- Setbacks vary according to Zoning District.



- Pools containing 24 inches or more of water depth shall include a fence, wall, above-ground pool walls, or similar enclosure surrounding the pool no less than 4 feet above the ground. Pools over 4 feet are required to have a removable or lockable ladder
- PADEP regulations require the discharge of water to be de-chlorinated and discharged onto grassy areas only.

Please note: dumpsters/PODS must be permitted and they must also be placed on property. Not in the street.

### Dumpsters and PODS require a permit.





Please keep in mind, if work is started prior to a permit being issued and paid for, the permit fees are doubled.

Property lines can be found by locating the property pins. If they are no longer there, you will need to contact a surveyor.

The above is a portion of the zoning requirements, not the complete sections. Find full ordinance on borough website.

Questions regarding the interpretation of the ordinance should be forwarded to the Zoning Officer by calling the Borough Office.

Storm water permits/exemptions will be needed for projects that include changing or adding impervious ground coverage.



# <u>INFORMATION FOR EAST PETERSBURG RESIDENTS RE:</u> <u>Door to Door Solicitors and Peddlers</u>

East Petersburg Borough frequently receives inquiries regarding persons going door to door and soliciting. With warmer weather soon upon us, we will be seeing more of this. Please review the following information about our solicitation guidelines and some suggestions for interacting with solicitors.

Solicitors within East Petersburg Borough must apply for and be approved for a license to solicit in the Borough in accordance with the Borough's Soliciting Ordinance.

Political canvassing, religious proselytizing, and distributing handbills are activities that do not require a license and are permitted by law.

Per the East Petersburg Borough Ordinance, solicitors must adhere to the following guidelines and rules regulating door-to-door solicitation:

Must cease solicitation upon owner or occupant request

Must obey posted "No Soliciting" and "No Trespassing" signs

Must carry and display their license while they are soliciting

May only solicit between the hours of 9:00 A.M. and 6:00 P.M. Monday through Saturday.

If a solicitor does not display and cannot produce a license, they may not be licensed to solicit within East Petersburg Borough and may be reported to the Northern Lancaster County Regional Police Department:

East Petersburg Borough maintains a list of current soliciting license holders on its website, which residents can reference.

Pushy, rude, or aggressive solicitors

Beyond the restrictions listed above, the Borough of East Petersburg does not directly regulate the demeanor of individual solicitors. Remember however, that <u>as a homeowner or occupant you may at any time ask a solicitor to leave your property</u>. Every resident has the right to feel secure in their home, should you feel threatened or unsafe based upon a solicitor's behavior, contact the Police immediately.

### How to Prevent Solicitors At Your Home

Prominently display a "No Soliciting" or "No Trespassing" notice on your property. Signs should be of a size that is easily visible to Solicitors who may approach your front door or main entrance.



It is illegal in East Petersburg Borough to solicit at a location where proper No Soliciting or No Trespassing signage has been posted. With or without a sign, residents should not ever be afraid to exercise boundaries with solicitors by refusing to answer their door or by politely stating 'no thank you' or 'not interested' and shutting and locking their door.

**Constitutional Rights of Solicitors** 

The First Amendment and the U.S. Constitution protect the rights of door-to-door solicitors and preclude the ability of a community to ban or significantly limit door-to-door sales. The U.S. Supreme Court has upheld free speech for commercial purposes, and the Borough's ability to restrict commercial door-to-door solicitation is limited to local regulations restricting the time, place, and manner of door-to-door solicitations. Homeowners and occupants, however, do have the ultimate right to determine whether solicitors shall or shall not be invited to their residences or property.
